### TRUSTEE RESOLUTION CALLING FOR AN ELECTION

**BE IT RESOLVED**, the Board of Trustees for Gardiner School District No. 7&4, Park County, State of Montana, will hold the Annual Regular School Election on Tuesday, the 7th day of May, 2019, which date is not less than seventy (70) days after the passage of this resolution.

The election will be conducted by:

Mail Ballot     Poll Election (the polls will be open from 12pm until 8:00 p.m.)

1. Elect two (2) trustees for a three-year term.
2. Possible approval of a General Fund levy to maintain the maximum General Fund budget allowed by state law. Actual amount of levy to be set no less than 30 days prior to the Tuesday, May 7<sup>th</sup> school election.
3. Possible approval of a Building Reserve and Technology Fund levy to operate and maintain school needs. Actual amount of levy to be set no less than 30 days prior to the Tuesday, May 7<sup>th</sup> school election.

If it is later determined that any portion of the election is not required, the Board of Trustees authorizes Shelby Detro, election administrator, to cancel that portion of the election in accordance with [13-1-304](#) and [20-3-313](#), MCA.

The following voting locations will be used for the election and the three electors of this district who are qualified to vote at such election are hereby appointed to act as judges at the election at each voting place as follows:

If any of these judges should not be able to serve, the election administrator will choose a replacement from certified judges.
